2017. It states that: "Antisemitism is a certain perception of Jews, which may be expressed as hatred toward Jews. Rhetorical and physical manifestations of antisemitism are directed toward Jewish or non-Jewish individuals and/or their property, toward Jewish community institutions and religious facilities".

Recommendation:

The AUU recommends the SRC to commit to working with the Australasian Union of Jewish Students (AUJS), as the peak representative body for Jewish students on campus in Australia and New Zealand, to ensure activist spaces, events and protests are inclusive and welcoming of Jewish voices and perspectives. There should be no pre-qualifications necessary for Jewish students to attend and/or feel included.

Recommendation:

Going forward, the AUU will formally recognise and publicise January 27, as designated by the United Nations General Assembly, as International Holocaust Remembrance Day; and encourage the SRC to work with AUJS in either partnering or sharing material designed to educate and commemorate the atrocities of the Holocaust.

Oscar Ong mentioned that he and Patrick Stewart went through the policies earlier in the day, and then briefly went through the alterations.

Patrick Stewart mentioned his meet-up with Oscar Ong earlier in the day and was concerned that the policy may only solve issues in the short run and that longer-running issues may arise and have been foreseen.

Patrick Stewart mentioned however there is only one real issue; that the clubs administration or clubs manager entering policies that the board would not resonate with.

Gary Sutherland mentioned that no extra policies will necessarily be entered without notification, and reassured the board has higher power and can step in if need be.

Hugh Sutton mentioned that instead of the board tying themselves up in words and policies, if dire circumstances arose, the election tribunal would deal with them at the time.

1. Perth Visit (16/07-19/07)

CISA Conference

I attended the CISA National Conference, being held at the Pan Pacific Hotel, Perth from 16th July till 19th July, which is attended by mostly international students' leader from all over the country.

16/07

Plenary Session: Value for Investment - Cocurricular Activities & Entrepreneurship. A broader outlook of Higher Education

A very brief mention was done on the rise of tuition fees but was more focused on the value international students getting out of it. The panel tried to measure the outcome through the student's employability and ability to get a job in Australia.

Workplace Exploitation: The Final Resolution

This was served as an informative session to the delegates. Fair Work Ombudsman talked about working rights and reporting methods. I've ensured and confirmed the commitment by the Department of Home Affairs that the international students' visa will not be pulled back if a report were raised by international students' which rights are violated by employer that have worked for more than 40 hours per week

CISA Public Report

This is the first ever public report done by CISA and I commend their effort in increasing the organisation's transparency. A summary of each of their department's advocacy is given. Their advocacy after the closure of institutions was very impressive.

Graduate Outcomes: WE all matter

The session was mainly informative about how certain organisations value international students, however, does not solve the main issues.

Australia: A Prism of Possibilities. Volunteering Experience with CISA Session This session talked about volunteering with CISA.

Plenary Session: Tertiary Education Providers Alumni Strategy: Supporting Future Global Leaders - with themes surrounding Alumni Networks, The Global Vision and providing outgoing students with the right real-world connections

This session talked about the value of alumni, which the university have already been working on.

'Combating Workplace Exploitation for International Students'

A review of Australian workplace rights and other human rights laws, and how these impact international students and other temporary residents were carried out. The discussion looked at the issues surrounding franchising in Australia, and what changes are needed to protect employees from exploitation in this setting. It was interesting where several federal legislations were pointed out to be discriminated against international students and temporary residents. Several solutions were suggested, and I will put these ideas forward to the working group with ISS.

18/07

Mental Health Workshop: Conquering the cultural stigma

This session focuses on normalising difficulties with mental health, challenges for international students and how problems can present for students, what to look out for in themselves and others and where to go to get reliable information and initial help. Leonie will discuss suicide with a focus on the importance of seeking help. Staying well and prevention of difficulties were discussed too.

Time to review the National Strategy for International Education?

One of the key recommendations of Australia's first ever National Strategy for International Education was the establishment of the world's only National Council for International Education. The Council includes 6 Federal Ministers and 11 Expert Members (including the elected President of CISA) and meets regularly. Established in 2016, one of the key roles of the Council is to ensure effective implementation of the Strategy. After 4 years now of operations, the CISA Conference 2019 provides a good opportunity, through this session, to explore how the Council is functioning, whether it is effectively implementing the National Strategy and even whether it might be time to update and refresh the Strategy. I was glad to be able to hear what the council were doing and provide my input in the potential refreshment of the strategy.

Plenary Session - National Peak Student Bodies

National peak bodies including NUS, CAPA and CISA presented what they have been doing for international students. I asked about the ineffectiveness of NUS's international officer which attended 2/5 executive meetings and handed in 1/5 reports (second report is the same as first) in representing international students and the answer I got was "every organisation have ineffective executive members". I also asked about what NUS had done for international students when approximately 21% income (affiliation fees) are from international students, the answer I got was "it is complicated, and our work mostly includes international students". I also asked about

the free education campaign which never include international students as part of the conversation, again, the answer was just "we follow the model of other free ed countries and it could be done"- with no acknowledgement they are living in Australia. The answer given by Desiree, President of NUS was very disappointing, showing their lack of leadership skills and understanding towards what they are fighting for. I believe if CISA were to receive 21% of the affiliation fees of NUS, more meaningful work for international student could have been done.

Panel: Student Engagement in Institutional Decision-Making and Governance-International Student Voice

We were presented the Student Voice project which the SRC is also part of.

Regulatory Closure of Education Institutions

CISA was involved in several education provider closures of their tenure, with the biggest issue spanning through Darwin, Sydney and Brisbane. It is seen that on the ground, the students were at a loss when they didn't know the procedures of a college closure or an ASQA review procedure, they were panicking about their visas, their tuition fees, their loss of investment, the accreditation of units etc. We were equipped with the knowledge to assist with college closures or know the processes should a student be at academic risk due to this as well. An opportunity for the session to discuss suggestion of future initiatives to improve between TPS and TEQSA. It was a very valuable session to me because we would never ever expected institution closure especially as an international student. The procedure taken was laid out clear to all of us.

Inspire, Aspire, Empower

This session have a strong focus on employability and the importance of employability. Along with themes around cultural integration – and the growing benefits of international and domestic student engagement/involvement.

Launch of IEAA's new student guide

A very useful guide for international student looking for employment were release. I am looking into linking this guide through our website.

Curtin University Guild- Finlay Nolan (18/07)

I met with the President of the Guild, Finlay and she provided an outlook of what their structure looks like. Their structure is similar to the AUU, where there is a SRC and an AUU Board, however, their SRC arm is bigger and have each individual departments. A two-year term were recently introduced to ensure continuity between the old and new council members. We also talked briefly about the online elections.

UWA Student Guild- Conrad Hogg (18/07)

Their student guild is huge, with clubs' spaces, café and retail spaces. Their volunteering department have been really successful, something we could learn from. Their president are the head of governance but also the head of operations as well. They have a similar grant program as us.

Both guilds have a much larger scale compared to the AUU. Although leased by the university, both guilds have their own spaces, which they rent out to cafes and have their own retail shops. They are even capable of furnishing the entire place which cost more than 1 million. Although with 50% compulsory SSAF funding, which amounts to \$2.8 mil for Curtin University, \$2.7 mil for UWA, it has not much difference with the AUU, what made them different to us, is the collaborations and long understanding with the university.

In conclusion, my trip to Perth was very rewarding and certainly very eye-opening what a student organisation can achieve with the empowerment from the university-something I will continue to advocate for the rest of my term.

After a recent study expedition to Waite campus I found a fantastic campus with better facilities for stress relief than the city. However these are in sub par state. The pool cues have no tips, the pool table felt is ripped and the ping pong balls were all cracked or broken.

Rather than just complain about this, my solution to the problem was to get rid of all the the broken ping pong balls and donated some new ones.

Next I ask the most approachable union president Mr Oscar Ong to repair the cues and felt of the pool table to revive this campus that is tucked away.





3. RCC

Kearin, Ali and I attended a presentation meeting of the RCC Survey Feedback with the consultants. After that, we had a follow up meeting with the university to analyse the results. After the analysis of the results, we had another follow up meeting. I trust that you have seen the results in our webpage too. I am very glad to say, through my meetings with university and advocacy, this year has been a huge progress in student representation, representing the AUU, I had a seat in the decision-making table- a great achievement worth for all students to celebrate. The AUU were considered as one of the key stakeholders and our opinion were valued and prioritised. In the best interest of all students in mind, the university and I sat together to talk through all the issues we had and together as a collective.

A meeting of "without prejudice" with Roberto Cardone from RCC to understand his thinking about the RCC being on campus next year was held after the week. The meeting overall was positive, and we had seen genuine intentions to work together with the AUU from the university's side. The draft plan indicates that Elder Hall will be used one or two nights per week, less infrastructure in Bonython Hall, maybe not use Scott Theatre at all, Barr Smith Lawns used to incorporate Neon forest with 1/3 free space, whole Maths Lawns will be used but the area around is accessible, reading room of the library will be activated, Goodman lawns & Hub for Clubs, Union House and cloisters will be used for events and displays and no sounds checks before 5pm.

4. Meeting the SA Minister for Education



I had got the chance to meet with the SA Minister for Education in one of the cultural dinners of our clubs. It was great to talk about the AUU and the value we add to students. We also talked briefly about the rebranding of the AUU which the minister has expressed his support behind the issue.

Union House Masterplan- Stakeholders Briefing (08/08)

The session talked about the plans and principles of the masterplan. The session was a starting point for discussion only. Nothing is set in stone, the consultation process is in its early stages and they have not yet met with all of the groups who will be part of the consultation for the Masterplan for Union House. Couple of issues that I've highlighted was Union House Level 4 for centralised AUU services and bigger prayer rooms.

The committee met up to discuss issues around intensives and block teaching. I catch up with Dave after the meeting (I was in the RCC meeting before) and updated what we discussed. The student groups involved previously were willing to be more collaborative to which he was pleased. I also talked about the several events coming up and MOU as a result of meeting with Inga. I was apparently quote, the best AUU President the AUU have had in 10 years, unquote!

Currently, the AUU student election cycle runs for a period of up to 4 months from June-September with certain tasks required to be completed by specific dates. With online election platform, other student associations complete a full election cycle within an average of 6 weeks with a polling period running between 1-5 days.

The current AUU budget for annual student election is approximately \$8000-\$10,000 and is supposed to cover staffing, printing, infrastructure and stationary. It is expected to exceed due to extended counting periods and additional staff requirements.

It should be noted that apart from financial costs, there is an increasing negative cost to the AUU's reputation as students and staff become less accepting of campaigning methods and engagement during election week. Thus, I am recommending the board to further look into the possibility of having online elections.

Recommendation:

That the Board actions Gary Sutherland to investigate the possibility of holding online elections.

Dear Board Directors,

Antisemitism is often dismissed as a phenomenon of the past, both in public debate and academic discourse. People mistakenly assume that Antisemitism is merely historical. The opposite of this is true. 2018 saw a 59% increase* in recorded antisemitic incidents and a huge increase in antisemitic activity occurring on campuses across Australia. *Report on Antisemitism in Australia 2018 compiled by Executive Council of Australian Jewry (http://www.ecaj.org.au/wp-content/uploads/2018/11/ECAJ-Antisemitism-Report-2018.pdf). Thus, we are recommending the following:

Recommendation:

- 1. The AUU condemns antisemitism in all its forms as defined by the globally recognised International Holocaust Remembrance Alliance (IHRA) definition. This is the working definition used by both Australian and international Jewish representative bodies. This is also the definition that was adopted by the National Union of Students on 14 December 2017. It states that: "Antisemitism is a certain perception of Jews, which may be expressed as hatred toward Jews. Rhetorical and physical manifestations of antisemitism are directed toward Jewish or non-Jewish individuals and/or their property, toward Jewish community institutions and religious facilities".
- 2. The AUU recommends the SRC to commit to working with the Australasian Union of Jewish Students (AUJS), as the peak representative body for Jewish students on campus in Australia and New Zealand, to ensure activist spaces, events and protests are inclusive and welcoming of Jewish voices and perspectives. There should be no pre-qualifications necessary for Jewish students to attend and/or feel included.
- 3. Going forward, the AUU will formally recognise and publicise January 27, as designated by the United Nations General Assembly, as International Holocaust Remembrance Day; and encourage the SRC to work with AUJS in either partnering or sharing material designed to educate and commemorate the atrocities of the Holocaust.

- · they would have no conflict of interest
- the focus of the role could be to is to assist students get out of debt and take control of finances to support independent living and successful engagement in their study
- Financial Counsellors are well placed to work in not for profit, community or church-based organisations who provide preferential support for those groups that are recognised as socially disadvantaged
- this role would be distinct from the EWOs and focus on debt management; budget skills; supporting access and referral to relevant and required community resources.

Recommendation:

That the AUU Board, in recognition of the importance of supporting students with financial issues, for the 2020 Budget, redirects the excess funds of NUS affiliation, other affiliations and NUS conference budget line item, with a total of \$18,600 to Student Care to create a financial advisor position to assist students regarding their financial enquires.
