## 4. Expressions of Interest\*

New Expressions of Interest - refer to appendix 2

 Recommendation: That the Clubs Committee considers the Expression of Interest submitted by Association for the proposed Adelaide Speech Pathology Society.

Birchall states that he is happy with the Adelaide Speech Pathology Society's Expression of Interest.

Qin asks when the Speech Pathology degree began at Adelaide University. She concluded it was recently and is happy with the application.

Recommendation: That the Clubs Committee considers the Expression of Interest submitted by Association for the proposed Adelaide Speech Pathology Society.

Lai asks the Committee their opinions on the Expression of Interest.

Qin asks Clubs Admin whether the club already exists.

Long states that there use to be a Pakistani Student Club on campus but their registration lapsed.

Hausler supports Longs statement, noting that the AUU disaffiliated the club after an extended period of no activity.

Action: Clubs Admin notify applicant that the Expression of Interest submitted for the proposed Adelaide University Pakistani Students Society was approved by the Clubs Committee.

Moved: Birchall Seconded: Qin Dissent: None Motion passed.

Action: Clubs Admin notify applicant of the success that the Pakistani Students Society' Expression of Interest.

3. Recommendation: That the Clubs Committee considers the Expression of Interest submitted for the proposed Society for Physiotherapy Students



### Long exits, 2.43pm.

Lai asks the Committee when the proposed Society for Physiotherapy Students was created. He voices that an application passed a few weeks ago which looked similar.

## Long re-enters with Zimmerman, 2.45pm.

Qin suggests that the proposed club could merge with the club from a few meetings ago. Birchall states he believes that this Expression of Interest should stand alone.

Kate interrupts conversation to notify the Clubs Committee and update the minutes to show that Zimmerman has arrived. Qin and Lai state that Zimmerman should have requested access to the Committee meeting and that he cannot be present.

Long states that Zimmerman had reached out to Gary Sutherland (General Manager of the Adelaide University Union) and he said that this was not in contradiction to any AUU rules or guidelines.

Birchall states that he had also invited Zimmerman to the meeting, and that he has a standing open invitation to any member of the Clubs Community who would like to attend.

Zimmerman states that due to his status as a Student Representative Council Board Director, by committee regulations he is entitled to be present at the meeting. He also states that the Clubs Committee reports to the board.

Lai states that is was not courteous for Zimmerman to not ask his permission, and he must leave the room.

Birchall asks under what authority states that the chairperson can remove him from the meeting. He states that he does not understand why the Committee chair is barring students from attending meetings, both Clubs, Board and SRC.

Qin states that she believes all Clubs Committee meetings are in camera.

Birchall states that meetings are only in camera if they are explicitly called to be in camera. Zimmerman stated that precedent was set last year by Ashley (Jayasuriya), who was meant to be allowed to be present at meeting as he reported to the Board. Zimmerman states that he is present as an observer and will not comment on proceedings. Hausler also confirms that Zimmerman did send through a request.

Lai states that he did not receive such request, and the Committee will follow the advice of Sutherland, that is the observer cannot influence the discussion, nor vote on arising matters.



Lai directs the discussion back to the Expression of Interest.

Qin states that according to page 35, the club themselves said they are similar to speech pathology, and re-iterates that perhaps they should collaborate.

Birchall notes that the committee has already passed the Expression of Interest for Speech Pathology, and that there is a genuine distinction between the clubs.

Recommendation: That the Clubs Committee considers the Expression of Interest submitted for the proposed Society for Physiotherapy Students

Qin states that the club appears very general and that there is significant overlap between the proposed Rhodes Society and other existing clubs.

Birchall asks Qin what clubs the proposed club would overlap with.

Qin states that there is overlap with the history, law and philosophy clubs.

Lai agrees with Qin, and adds their object to 'promote discussion' is similar to the Debating Society.

Birchall disagrees with Lai and Qin, stating that debating has a great deal of structure and competition and this differs from the objectives of the Rhodes Society. He states that if clubs are offering value, they should succeed on the will of the students, and unless there is a direct overlap our opinions should not matter.

Qin states that she will not second the recommendation when it is moved.

Qin states that she is not familiar with this Church, however the clubs community already has

quite a few church clubs on campus.

Birchall states that is the committee wants to be consistent, this club should be rejected for

being too similar.

Lai asks how many church based clubs we have on campus.

Haulser states that some church-based clubs have not affiliated with outside churches, and

that the university has issues with clubs affiliating with off campus churches in the past. It is

difficult to determine what is too similar in faith and politics, however the committee has to

ask whether this club would fill a space in the community or not.

Committee acknowledges that the Major Activities Grant application was already passed via circular resolution.

### Other grant applications:

1. Recommendation: That the Clubs Committee agrees for \$249 of the Clubs budget to be used to pay for the damage as a gesture of goodwill.



Long explains to the committee the chain of events outlined in the appendix, and states that Clubs Admin suggests the committee agrees to pay as a gesture of goodwill, and asks the committee what they recommend. She states that the reason they had to borrow the equipment in the first place was because the AUU is not currently hiring out equipment due to COVID restrictions.

Qin asks Clubs Admin where the funding would come from.

Long states it would come from the Club's grant budget.

Lai states that he would not want to club to go bankrupt over such a matter, and is open to supporting them if they do not have the finances themselves.

Birchall states that the club should be responsible for their actions, and that they did not follow the procedure of calling JP Light and Sound once they realised the microphone is broken. He states that he is happy to allow money to be granted, however he would like the club to send a written apology to JP Light and Sound as to not negatively prejudice other clubs.

Lai asks Clubs Admin whether we can find out Global Health Insights financial status.

Long states that Clubs Admin could potentially ask for a financial statement however Global Insight do not technically have to provide. She also notes that it reflect poorly on the AUU if we continue to keep JP Light and Sound waiting.

Lai asks how much of their grant budget has been accessed already.

Wilkinson exists to check the grants tracking sheet.

Wilkinson confirms that Insight Global Health has only used \$188.20 of their minor grant, and they could use the minor activities grant to pay the owed \$249.

Birchall suggests that Clubs Admin could get in contact with the Club and ask whether they have already paid.

Long states that this grant would be a reimbursement as this issue was flagged with Clubs Admin 4 or 5 weeks ago.



Recommendation: That the Clubs Committee agrees for \$249 of the Clubs budget to be used to pay for the damage as a gesture of goodwill.

Moved: Birchall

Seconded: Qin

Action: Clubs Admin contact Insight Global Health of outcome and process minor activities grant for \$249.

Qin states her computer is about to run out of battery and exists to change devices (3.32pm).

## 7. Any other business.\*

- 1. Grant Guidelines updated (refer to meeting 05/05/21)
- 2. Proposed Amendments to Clubs Administrations Policy- proposed by Birchall

Birchall asks Lai why Ong ignored the recommendations of the Clubs Committee regarding the proposed amendments to the Clubs Administration Policy. He states that we discussed in the meeting previously that the wording was insufficient and they committee did not pass the document. However, the provisional were still put to the board without any consultation nor change.

Lai states that he did speak to Ong about it, but Ong has the right to take it to the board as he sees fit. He asks Birchall whether he agrees with the policy's intentions.

Birchall states that he does agree with the intentions in pervious minutes, but the provision is littered inconsistencies, from unclear objectives to grammatical errors. He states that he does not see the provision as fit for purpose and the role of the Clubs Committee to discuss these matters were overlooked.

Lai states that he cannot speak on behalf of Ong, and does not know whether he has read the minutes. He asks Birchall what he wants to achieve bringing this issue up at the meeting. *Qin returns at 3.36pm* 



Birchall tells Lai that he wants to know why his proposal was overlooked especially as the Committee, including the chairperson, agreed that the provisions as they stood were not sufficient.

Qin states that the matter was discussed at board level, and that the Board Directors were happy with the wording so it passed.

Wilkinson states that the meeting must move as another person has booked the board room for this time.

People in person moved from board room to small meeting room, entered 3.41pm.

#### 3. Names unredacted in agenda- proposed by Birchall at the meeting

Birchall asks the committee chairperson why the name on the Expressions of Interest were un-redacted despite the committee agreeing to keep anonymity in all club applications. Lai states that this was something he initially did not consider important, but now he believes that the committee cannot approve an EOI without knowing the application. He states he believes it important to know whether the applicant has integrity. Birchall states that he understands what Lai means, but it is not a valid reason. He states that having a name on the application unfairly biases applicants, and creates a position where some clubs are unfairly treated. He states that Lai and Qin agreed last time. Lai states that he does not want someone applying to run a club who is not equipped to run a club.

Birchall states that this is not the test of whether an Expression of Interest is approved.

Lai states that much like a resume, you need a name to the credentials. He also states that the policy allows the chairperson to add any information they deem important to the application.

Birchall states that both Lai and Qin agreed to the redaction at the last meeting, and that the committee should have been informed about the chairperson's shift in stance. He states that it would have been good governance for this to be outlined in an email rather than having to ask Clubs Admin about the change. Birchall also states that no one replied to his



final email and if we can authorise clubs admin to set up regular meetings. *Birchall is muted* by chair.

Qin states that having meeting organised in advance does not work for her schedule.
